Karakoz wa Ewaz Shadow Theatre is practiced for the purpose of entertainment by young men at public spaces, and in front of an audience of men or a mixed audience. Every show is presented by a single leading performer who moves the characters and tells the story.

This tradition is part of how Syrians across age, gender, ethnic and religious groups define their cultural heritage today. So if you ask a Syrian who is over eighteen or sometimes even a child about a Syrian tradition that is of theatrical nature, the Karakoz wa Ewaz Shadow Theatre would naturally come up as an answer.

There are two performers who still present the shows, but also several people who own puppets of Syrian characters, and many others who know the details of the tradition, including a researcher who has registered about 40 of the traditional stories used for this art and published them in a book.

This performing art is practiced in public spaces, like on the streets and in cafes, since it doesn't need complicated equipment or a proper stage. The performer brings his materials with him. It is mostly presented today in festivals organized by the Governorates of Damascus and Aleppo in historic quarters like Souq Sarouja, but also recently at Syria's opera house.

This element constitutes part of Syrian's definition of their culture today in each of Damascus,

Aleppo, Homs and Hama.

# 9. Process of elaborating the nomination

In order to elaborate the nomination, interviews will be made with current performers and families of late ones, since they still hold information about the tradition and some of them still own Syrian puppets. A focus group will be held with them and decision makers at the Ministry of Culture in order to analyze problems and brainstorm best measures to safeguard this element while it remains part of the public culture in Syria.

Furthermore, a lecture directed to the public on whether this element should be saved will be held, in order to measure public interest in it, especially from the side of intellectuals, researchers, journalists and workers in the cultural field.

Practitioners have already given their consent to registering Karakoz wa Ewaz Shadow Theatre on the urgent safeguarding list, and the Ministry assesses a valid public interest in saving this tradition.

The Ministry of Culture, Department of Popular Heritage will be responsible for the preparation of the nomination file, collaborating with researcher Muneer Kayal who is a prominent researcher of Syria's heriatge and who has worked on the topic before.

We will also work with photographer Hany Hawasly and filmmaker Zaki Cordello. No one could be more competent to do the task of writing the storyboard for the film (in collaboration with the researcher and the Ministry) then directing it than Mr. Cordello, who is a filmmaker and teacher of theatrical arts, and who practices this performing art today.

# 10. Preparatory measures to be supported financially by this request

While the Ministry of Culture, Department of Popular Heritage can support a researcher to elaborate the nomination file, it needs UNESCO's financial support to create the 10 minute film, prepare professional photographs, arrange for the researcher to travel to Aleppo, Hama and Homs to find out if there are any left owners of Karakoz wa Ewaz puppets or stories, or even living practitioners that the Ministry is not aware of, and organize the focus group and public consultation through a lecture with relevant and interested communities as mentioned in point no. 9.

Two public events of Karakoz wa Ewaz Shadow Theatre will be organized in order to ensure the existence of opportunities to shoot for the creation of the film and photographs, since such availability could not be left to luck.

# 11. Timetable of the project

November, December 2011: Research, including interviews, travel and holding the focus group will be done and will provide background for preparing the film's storyboard

January, February 2012: Two public events will be organized, where photography and shooting for the film will be completed. The deadline of finalizing the photos and the film (including subtitles) is 29 February 2012.

March 2012: The public lecture and discussion will be held in Damascus, including a screening of the film and sharing of the draft nomination file. Deadline of finalizing the nomination by the researcher is 15 March 2012.

# 12. Budget
