Kanuri Development Association has in the past jointly organised and coordinated activities relevant to the convention including the Nigerian government programes on the domestication of the 2003 convention through the National Institute for Cultural Orientation as well as the UNESCO office in Nigeria. The event was organised on June,2011 in the city of Enugu in Enugu state, Nigeria.

KDA participated in Series of meetings with the Nigerian Minister of culture and tourism ,the Nigeria's UNESCO Ambassador in Paris France as well as the permanent Secretary Ministry of Culture federal republic of Nigeria in Abuja-Nigeria.

Kanuri Development Association participated in the preparation of nominated elements at the national level. We played significant role when the 'Argungu international fishing and cultural festival' was Inscribed in 2016 (11.COM) on the Representative List of the Intangible Cultural Heritage of Humanity. KDA played some vital roles in the diplomatic lobbying of UNESCO-ICH member state for consideration of our (Nigeria) nominated element presented at the ICH – Session (UNESCO-ICH 11 that was held in Ethiopia.).

KDA keeps offering its expertise and technical supports to the national programmes in Nigeria on the 2003 convention. For instance, during the Enugu Workshop on the Domestication of the 2003 Convention in June,2011 in Nigeria, the Nigerian Government in partnership with the Nigeria UNESCO office jointly organized the workshop on the convention, but requested the technical assistance/expertise of the UNESCO accredited NGO'S /Experts in Nigeria to assist with our technical expertise relevant to intangible cultural heritage in the workshop, which we did.

KDA organises workshops after every ICH Session and related training it participated in, at each time. This workshops are aimed at mainstreaming of ideas generated from every program it participated and or share ideas from the programs. For instance, after the UNESCO Capacity building workshop on the 2003 convention that was held on 30th September-2nd October 2011 in Libreville the republic of Gabon, we organised similar train-the-trainers workshop in the local language for our community on January,17 2012.

Same applies to the all other programs KDA is represented.

we have been developing awareness raising campaigns/activities at the grass root level from time to time especially during annual cultural events in the local dialects (Kanuri and sometimes even in the Hausa local language for a greater understanding of the convention.

We are presently working on preserving the Kanuri language through documentation as the Kanuri languages is presently under the threat of decaying as a result of colonisation on their lands by the colonial societies who imposes other non-Kanuri languages on them as a commercial language in their territories. In view of this the Kanuri language nouns/words are presently incessantly been replaced by the nouns of other stronger invading languages including English and the Hausa languages in the North-Eastern parts of Nigeria where we are mostly based.

KDA is also working on identifying/inventorying and documenting stories, histories and many other intangible elements of the Kanuri culture and language.

Furthermore, we are also currently working towards recording and documenting some Social practices (Cultural expressions like the Kanuri tribal marks and sporting games such as "JOKOR") and other associated festive events, Knowledge and practices of the Kanuri people.

With time we are also hoping to develop other aspects such as Traditional craftsmanship.

As a result of our long time experience and cooperation as well as consultation with a wide range of National, regional and international Bodies such as United Nations Convention on Biological Diversity, African Union (NEPAD), United Nations Human Rights Office, UNESCO, United Nations World Intellectual Property Organisation, the British Department of International Corporation, the Stockholm Convention and many others including the Nigerian government we are quite familiar with evaluating and analysing documents.
