Good Practices, AIP-IAP has been invited to join the WG and has since then produced several Opinions on Portuguese tentative nominations.

In 2020, AIP-IAP was invited by the Ministry of Culture to be part of the National Network of Intangible Cultural Heritage, thus contributing to the implementation of the National Strategy for Intangible Heritage which will begin in 2021.

Taking into account the mission of the Associação Internacional de Paremiologia / International Association of Paremiology (AIP-IAP) and considering the interest of the Portuguese National Commission for UNESCO (NCU), both institutions established, by 7<sup>th</sup> May 2016, a protocol for the creation of the UNESCO CLUB of Paremiology (UCP), settled at the same address of the AIP-IAP.

The AIP-IAP and the UCP works together to foster an UNESCO Club specialized in the area of paremiology and related fields aiming, in line with the principles of the UNESCO Constitutive Act, to cooperate with local, regional or international institutions, encouraging the defence of the values proclaimed by UNESCO, seeking effective ways to achieve them, namely through the production of teaching materials to enhance citizenship.

**B.2.** Describe your organization's cooperation with competent governmental bodies for the safeguarding of intangible cultural heritage (Article 13), including existing institutions for training on and the documentation of ICH (OD 154).

The AIP-IAP/UCP adopted as a general policy for the promotion, dissemination, consolidation, transmission and safeguarding of intangible cultural heritage, direct contact with government authorities, including the Parliamentary Committee on Culture, Communication, Youth and Sport (12CCCJD) of the Assembly of the Portuguese Republic. Contacts have also been made with the Presidency of the Republic, with the Offices of Prime Ministers, Ministries (Agriculture, Culture, Justice, Foreign Affairs, Social Security, ...), State Secretaries and the Regional Directorate for Culture of the Algarve.

The AIP-IAP/UCP participated in the:

- VI and VII Fairs of the Mediterranean Diet, Tavira and was present with an advertising stand, culminating in the Municipal Market with the *"Gentes do Mercado"* project. Proverbial performance and panels were fixed there until today.

- Il Feira dos Chocalhos, in Alcáçovas and in Mercado Fora d'Horas, Silves. In both, a stand was made available to publicize activities and gatherings around proverbs.

Others examples with Tavira Municipality:

- "Week of the Child and the Environment", with more than 1200 children;

-Festivals "A Palavra entre das Artes", integrated in "Viva a Primavera" Program: conferences, exhibitions on proverbs.

Due to the relevant activity, Tavira Municipality provided a space for the AIP-IAP/UCP headquarters.

"The High Sponsorship of the Prime Minister of the Government of Portugal" was given to 4 ICPs

organised by AIP-IAP since 2008; the "*High Sponsorship*" by NCU to the ICPs, as well the participation on colloquia and the cooperation with embassies (Czech, Polish, Russian in Portugal, and Portuguese in Russia).

AIP-IAP annually reports its activities to the following entities: Portuguese National Commission for UNESCO, Municipality of Tavira and Regional Directorate for Culture of the Algarve, region where AIP-IAP has its headquarters.

In Portugal, AIP-IAP is part of the Working Group for the Intangible Cultural Heritage to assist the Portuguese National Commission for UNESCO in the evaluation of nominations to the Convention's Lists and Register od Good Practices.

The AIP-IAP/UCP, as one of the eleven Iberian NGOs accredited under the Convention for the Safeguarding of Intangible Cultural Heritage, participated in the II Meeting of Iberian NGOs (Nov2019) where it had the opportunity to discuss aspects related to the preparation of topics to be presented at the International Forum of NGOs. During the two days of the meeting, the AIP-IAP/UCP presented examples of good practices for safeguarding the intangible heritage, with a natural emphasis on the importance of proverbial use as an aggregating pole for interdisciplinary practices.

The AIP-IAP/UCP participated in the preparation of two Opinions: one for the *Proposal for Registration in* the Representative List of the Intangible Cultural Heritage of Humanity and another for the Proposal for Registration in the Register of Programs, Projects and Activities that best reflect the Principles and Objectives of the Convention. The AIP-IAP was also one of the entities that signed a letter of support for the Transnational Candidacy for the Registration of the Mediterranean Diet as an Intangible Cultural Heritage of Humanity.

The active participation of AIP-IAP/UCP presents the national and international aspects, always in the double perspective of intercultural and intergenerational approaches, aiming at the realization of its statutory objectives in favor of the UNESCO ideals. The way in which AIP-IAP/UCP covers various groups in society is varied and suitable for each target audience.

AIP-IAP/UCP directs its cultural and educational programs for communities with incidence in Algarve,

Alentejo, Lisboa and less in central, northern, Madeira and Azores.

Examples:

- "Traveling through distant lands: another looks at the heritage universe", with impact on the material heritage (Roman Ruins of Milreu) and the immaterial heritage (proverbs); it makes known existing native languages along the circumnavigation trip from Fernão de Magalhães for students in a basic school-Faro. - "The locomotive of Twim" involved the Polish embassy, the municipal library of Tavira and all schools in the municipality of Tavira. After hearing the staged story, the children observed the exhibition and, in groups, tried to reproduce, in drawings, what they had seen. With the help of teachers, they associated proverbs with drawings that were displayed in the library. The project lasted 3 months with the participation of around 500 children.

- universities encouraging research in paremiology and related fields (Algarve, Lisboa-Portugal; Vermont-USA; Cape Town-RSA; Massey-New Zealand). University research centers (CET-UL-Portugal; SKS-Finland). - groups:

- prisoners - working on illustrated proverbs and doing one exhibition (Lisboa and Beja);

- International Rotary Club of Estoi-Faro - comparing proverbs.

- individuals: "15 musics for 15 proverbs", by pianist Bruno Belthoise-France.

The AIP-IAP/UCP promotes the connection between different sectors of society using the media to reinforce the importance of preserving the ICH, recalling the proverbial traditions and expressions in use in the region or locally. For this, we always communicate to the media and to local, regional and national authorities. In the case of partnerships with the authorities, they themselves broadcast on the appropriate social networks.

The connection to the research institutions/universities (*Minho, Porto, Madeira in Portugal; Zagreb-Croatia; S. Petersburg-Russia;, Caceres-Spain; Białystok-Poland; Maputo-Mozambique; Piaget-Angola; Bologna-Italy; Florence-Italy; UFRJ-Brazil; Brno-Czech; Vesprem-Hungary; Charles Univ-Prague; ADED-Argentina; Institute of Lithuanian Literature and Folklore*) is done either through the face-to-face actions made directly by the AIP-IAP/UCP, as well as by the associates who exercise their research activity and, thus, influence the ethnographic studies related to their areas of knowledge. As an example, we mention the growing internalization of the ethnomathematics importance for the study of traditional games and the use of proverbial expressions present in Mathematics.

The AIP-IAP/UCP facilitates the access to the ICH by making available bibliographic references of published articles (national and international) and offering the works edited by the AIP-IAP/UCP to libraries, individuals of recognized competence in the defence of the ICH. Of particular importance are the proceedings of the fourteen Interdisciplinary Colloquia on Proverbs (ICPs), which are recognized worldwide and referenced in scientific journals.

Due to the pandemic situation Covid19, activities of AIP-IAP/UCP were carried out on online platforms. This fact greatly increased the visibility of AIP-IAP/UCP, projecting it even more worldwide.

AIP-IAP/UCP in all its activities aimed at the general public draws attention to the urgency of passing the testimony to the youngest and the importance of incorporating, at a higher level, action programs that include interculturality as a way to preserve the ICH. Through its associated researchers, spread across five continents, it responds to the safeguarding of the ICH at a global level and contributes to the unity between peoples and cultures.

AIP-IAP/UCP has developed appropriate tools for the integration of intercultural dialogue and the promotion of different languages, including native languages. As an example, we cite the series of 10 European proverb books. They allow schools and universities to learn languages and cultures through proverbs. It involves teachers, parents and others interested in acquiring knowledge and skills, agents in the dissemination and preservation and facilitators of ICH transmission in the community, namely by young people. Participatory methodologies are always privileged through exercises presented in these books.

The transmission of knowledge through non-formal means is often done through associates who encourage their interlocutors to use proverbs in their daily lives. For example, the celebrations instituted by UNESCO and other organizations are grounds for the collection and dissemination of the ICH.

Cultural visits, exhibitions, cultural itineraries in heritage spaces have been made in cooperation with local, regional and other institutions dedicated to this purpose. The AIP-IAP/UCP disseminates the ICH through ICT, the social networks of, and the media.

Over the years, AIP-IAP/UCP has intensively shared varied documentation with other individuals and academics. The minutes of the fourteen colloquiums already held allow the sharing of information related to the areas of intervention of each participant in the domain of ICH. The diversity of items covered includes theoretical aspects and good practices in their countries of origin. AIP-IAP/UCP has maintained links to international research and documentation centers, museums and libraries.

As an example of regional cooperation, we cite the Lycée International de Saint-Germain-en-Laye, the only UNESCO center outside Portugal that has used the paremiological theme as a learning / teaching strategy and with the collaboration of a research associate professor at the University of Limoges.

With regard to regional cooperation, AIP-IAP/UCP relies on the scientific work of an associate, president of the Association and Dissemination of Distance Learning (ADED-Argentina), not only with its scientific work but also with connections to communities through interdisciplinary sharing with others in Latin America.

AIP-IAP has come to benefit from the UCP creation since there is a harmony of purposes and both are oriented towards the promotion of UNESCO's ideals. However, the closer proximity of the UCP to local community allows for a more informal, less rigid and easier integration into national/international networks of associations, centers, and UNESCO clubs over the world as the as the case of Korea Cultural Heritage Foundation. *"United, we win; divided, we loose"* and *"Unity is strength"*.

AIP-IAP collaborates with the Portuguese National Commission for UNESCO in preparing opinions on proposals for the integration in the List of Intangible Cultural Heritage in Need of Urgent Safeguarding, and for the Registration in the Representative List of the Intangible Cultural Heritage of Humanity.

In the future, examples of good practices carried out by AIP-IAP/UCP are increasingly necessary, especially with an emphasis on paremiological themes, an authentic universal treasure, interdisciplinary and intercultural.

AIP-IAP is an international association and, as such, has members from 48 countries (5 continents), many of them speaking English and/or French beside their mother languages. Seven AIP-IAP/UCP staff members have a very good command of English and French. Some of them have a good command of Portuguese (the 6<sup>th</sup> most spoken language in the world). Each of the other members

of the AIP-IAP/UCP has an exceptional command of their mother languages, and of these, many dominate other minority and native languages such as: Portuguese, Spanish, Italian, Russian, Germany, Greek, Estonian, Finnish, Irish, Lithuanian, Polish, Czech, Uzbek, Japanese, Malthese, Bakossi, Welsh, Quibundo, Changana, Maori, Shona, Basoto, Kikongo, Creoulo, Suali, Yoruba, Umbundu, Concani, Sami, Ligur, Mirandese, Catalan.

The spectrum of specialties of the members of AIP-IAP/UCP is vast with a greater focus on linguistics (literature, history, mathematics, natural sciences, economics, agriculture, psychology, sociology, medicine, politics, military sciences, ...). This multidisciplinary experience has been applied, in a relevant way, in the various, interdisciplinary and international colloquiums, which are held annually, and where knowledge is updated and shared in its links with paremiology.

On the other hand, in the various activities of the AIP-IAP/UCP the participants interact with the members of the association showing common points of view observed from different perspectives. Examples of what we have just said are cooperation with doctors, psychologists, economists, military and other professionals.

As an international organisation, AIP-IAP has members in several countries, with international experience in different areas of knowledge, most of whom have been involved in international projects and activities throughout their professional life.

The annual organization (since 2007) of ICPs lasting eight days with an average of 70 participants from around three dozen countries from the five continents, reveals competence/capacity to hold events of this kind nature, with wide reach and with a variety of activities that includes cultural visits, concerts, exhibitions, conferences, ... This is a good example to apply local experience to an international context.

AIP-IAP, through the organization of 15 ICPs, acquired great experience at international level, as can be seen by the objectives and themes for debate. Sharing knowledge, each year, state of art in paremiology is updated.

ICPs have contributed to mutual understanding of peoples/cultures in the globalizing world and, particularly to the preservation of intangible cultural heritage. Some activities carried out throughout the colloquia are examples of good educational practices and have been replicated in other cultural contexts. Cases of examples shown in the ICPs are reproduced in St. Petersburg (Russia) and Massey (New Zealand) universities and constitute an asset for accreditation of AIP-IAP as a pioneer institution in the pedagogical use of paremiology.
