

KADEM is an NGO aiming to solve the problems and barriers faced by women in all areas of life. With this mission, KADEM is carrying out various solution-oriented projects, good practices, summits, congresses, international programs and women network in all around the world. The vision of the foundation is to be a pioneering and accessible NGO with its local, national and international events and activities related to gender equality, discrimination and discriminatory laws and policies against women.

The foundation is one of the three associations in the executive board of the Women20 (W20) summit which was organized for the first time in G20 during the presidency of Türkiye in 2015. KADEM has been contributing to the work and studies of W20 in every field by participating W20 summits since 2015.

KADEM also works in academic field, it supports many scientific research and studies of various disciplines related to gender and women by publishing in its peer-reviewed academic journal called "KADEM Journal of Women's Studies".

KADEM's another mission is to care and protect family and its values which also has been providing the transmission of intangible cultural heritage (ICH) elements for centuries. Within this scope, the foundation organizes courses, workshops and training related to traditional craftsmanship not only to ensure the representation and empowerment of women in social and economic life but also to raise awareness of ICH among women and youth. The foundation supports ICH events and activities related to social practices, rituals and festive events.

KADEM organizes traditional cuisine courses and festivals of ceremonial food days like "Ashura" in its regional offices. Women learn the history of the dishes and how to cook them in these courses. At the festivals and special events, women and all the local people join the ceremony and they celebrate these ceremonial days with traditional practices.

In Oral Traditions and Expressions domain, KADEM organizes many events such as traditional story telling events and workshops, reading poems, novels from women poets and writers.

Performing Arts domain is the domain which KADEM organizes traditional and modern theatre, music and folk dances performances in festivals, workshops and training courses.

Practices related to Social Practice, Ritual and Festive Events domain, KADEM organizes and carried out events and projects which contains engagement/wedding ceremonies, traditional festive events and folk games.

KADEM's most activity is in the domain of traditional craftsmanship. It organizes many trainings and courses related traditional craftsmanship in the provinces where it has representative offices.

KADEM is also active in traditional cuisine, sacred and ceremonial dishes. The foundation established many food cooperatives according to the interests and experiences identified in line with regional needs.

B.4. Description of the organization's activities

KADEM has been working for the equal and fair participation of women in all areas of life since the day it was founded. In addition to the academic and discursive studies, KADEM also supports women by carrying out projects and practices that will empower them economically in areas where women are most active. For example, with the representative offices in 53 provinces of Türkiye, women are directly reached out and their current situations and needs are learned by KADEM staff and workers.

Our representative offices mostly carry out activities according to local needs. By supporting the opening of women's cooperatives in provinces where women make mostly rural and traditional production related to ICH and make income from their productions. By producing a variety of foods in traditional Turkish cuisine, women can make both national and international sales. Tarhana, pickles and tomato paste varieties; varieties of pasta, noodles, Turkish ravioli; many traditional products such as jam and hazelnut cream varieties are being produced.

In addition, in the provinces, courses and cooperatives are opened in the fields of traditional handicrafts and the development of traditional production capacities and generation of income through production are supported by KADEM. In our 53 representative offices, trainings in areas such as copper, weaving arts, wood carving, filigree, jewellery design, rosary and natural stone embroidery; marbling, calligraphy, illumination have been organizing. Moreover, these areas are supported through establishment of cooperatives in nearly 20 provinces.

In terms of traditional production, traditional knowledge and skills are kept alive through trainings

and cooperatives and transmitted to younger generations. KADEM also carries out media campaigns and promotional activities for women who are the pioneers of humanitarian studies, science, literature and cultural heritage in order to raise awareness of their work and studies and also aiming to encourage women for being new pioneers of different fields of social and scientific studies the future. With this objective and responsibility, KADEM is making field research of living pioneering women for inventorying them and their experiences, knowledge and skills for transmitting the future generations.

KADEM has published the "Declaration of Principles on Women's Rights" with its researches and experiences aimed at the agendas that concern women in all areas of life. In addition, every year, it carries out public service announcements and awareness campaign activities related to important days that concern women.

With 53 offices in Türkiye, KADEM has 5+ thousand volunteers, 500 members and 130 professional employees. Some of our representatives and members work professionally or have interest in the domains of intangible cultural heritage. From all around Türkiye many of our members and volunteers have knowledge and skills related to intangible cultural heritage. Some of them are also bearers, practitioners and member of a community related to intangible cultural heritage.

The events, projects or workshops of intangible cultural heritage are organized by KADEM members or volunteers in the provinces in cooperation with local administrations or other related NGOs.

As examples, KADEM organizes women storytelling, reading poems, novels of women poet and writers in provinces with its expert women members and volunteers. The organization has many members who is practitioners of folk music, dances and theatre performances. These members are organizing many events in provinces. KADEM is also making cooperation with its members on provinces for organizing social practices, rituals and events according to the traditional customs of the provinces. These practices and rituals are taking place in festive events and activities. By establishing many traditional cuisine cooperatives, KADEM is also active in traditional cuisine at provinces by its practitioner members and volunteers. Traditional craftsmanship is KADEM's most active domain in terms of intangible cultural heritage. Many of organization's members and volunteers work as traditional handicraft trainer or craftspeople. They have been organizing training programs, workshops and courses since KADEM were established aiming to transmit the traditional handicrafts to next generation as living heritage.

As aforementioned in B.5, KADEM has many ICH bearers and practitioner members and volunteers in its representative offices around Türkiye. Within this context, the organization has a

wide network related to intangible cultural heritage. KADEM are organizing its events and activities by using this wide network of ICH bearers, practitioners and stakeholder NGOs. Organizing and participating events and activities with this wide network and stakeholders are not only promoting the ICH practices in various domains but also raising awareness and ensuring viability of intangible cultural heritage at local, national and international levels.

As examples, at the 5th International Women and Justice Summit, KADEM organized a biannual event which the theme of it was "Cultural Codes and Women". During that event "Fabrics Atlas of Türkiye" exhibition was held with the cooperation of practitioners that includes many old traditional clothes with old fabrics of Türkiye. Thousand of participants from the Summit visited this exhibition which promotes intangible cultural heritage of Türkiye. The practitioners had able to host the visitors and explain the cultural meaning of the traditional clothes, fabrics, knowledge and skills of their living heritage. The organization also hosted an international event in cooperation with cooks who have reputation and an important role in traditional Turkish cuisine. KADEM is also in cooperation with women and girls who practice traditional handicrafts at various national and international events. At these events the organization is welcoming participants and guests by giving souvenirs of traditional handicrafts which are made by trainee women and girls who are participating courses or having education in vocational schools.

KADEM is also participating many forums which themes are women. The organization discussed different aspects of women's entrepreneurship and women's cooperatives in the UN Commission on Status of Women NGO Forum. In parallel with the experiences we had the cooperatives that are strong entities where intangible cultural heritage is being promoted and safeguarded.




