The Community Center of Akhmim, a pioneer experience in protecting Egyptian Heritage

The city of Akhmim sits on the eastern bank of the Nile, some 200 km north of Luxor. Its main crafts were handweaving and embroidery. Textiles were made using linen threads, cotton, silk, and wool. While embroidery uses silk, golden and silvers threads.

It is significant that, when referring to the city, the geographer Strabon (ca. 64 BC-ca. 30 AD) does not mention anything except the ancestral presence of weavers.

Famous for the majority of Pharaonic and Coptic textiles that are exhibited in the world's greatest museums, Akhmim still has a good number of hand looms producing cotton textiles with various patterns allowing to compose traditional or modern designs.

The Association of Upper Egypt Association established the "Akhmim Community Centre" with the aim of enhancing women in this city, as women make more than half of its population. In order to achieve this human development, the Association began to teach and train girls and women to engage in the crafts of hand weaving and embroidery, since it was the main occupation of the people of Akhmim thousands of years ago, both men and women. Hand weaving dates back to the Pharaonic times, while the brilliance of embroidery with silk, gold and silver threads dates back to the Coptic and Islamic eras.

With regard to oral customs and traditions, most forms of traditional embroidery are inspired by Egyptian academic references and museum heritage, present in Egypt and abroad, and have origins that are referred to. The forgotten aesthetic decorations are brought back to life on new artworks, so that they will not disappear, as well as topics of free embroidery (free art), most of which come to record happy or sad customs, religious and social traditions, practices and celebrations of rural or bedouin society in Upper Egypt or in Egypt in general. And in order to stimulate the creative imagination of the women artists, folk tales, travels and excursions are organized, and new embroidery artworks stemming from the heart of the Egyptian heritage are born. While the decorations of the hand-woven fabric produced by the Centre go back to the Pharaonic civilization (key of life, scarabeh, flowers...).

We are intending to create a local museum of handweaving and embroidery in our Community Centre of Akhmim to preserve this heritage from extinction. The project is ready and we work on the financing.

B.4. Description of the organization's activities

Sixty years ago, and answering a request from AUEED, a team of the international women's Grail movement has been settled in Akhmim in the premises of a disused school, without any pre-established plan, encouraged by the founder of the AUEED, tightly attached to the rich heritage of this locality.

The new created "Akhmim Community Center" was dedicated to girls from underprivileged backgrounds who had not attended school. The fact of meeting together, helped them to express themselves in freedom, through games and theater scenes of their own composition.

These girls expressed the desire to be productive. Nothing better than to build on the textile tradition of this historical city. From fabrics acquired from weavers' workshops, tablecloths decorated with openwork fringes were born. Some women wanted to embroider on these fabrics, following the example of the workshops run by social pioneers in various villages. The successful participation in a handicraft exhibition in Cairo in 1963 gave them the courage to develop the production. Since then, an annual exhibition of Akhmim Community Center products is held regularly in Cairo.

Rather than embroidering butterflies and flowers, the Center preferred to draw inspirations from the patterns found on ancient textiles dating from the Greco-Roman, Coptic and Islamic eras, thus perpetuating a centuries-old tradition. Soon after, some of the girls wanted to produce spontaneous designs through embroidery, each refining a very personal style over the years. Their embroideries present scenes of daily life, rural sides where trees and palm trees dominate, as well as compositions inspired by landscapes they discovered while hiking outside the city of Akhmim, where women are confined to their dark houses. Much effort has been made to protect the artists from outside influence and preserve the authenticity of their expression.

In 1971, in order to support the Center's own needs, looms were installed, and Center members were introduced to weaving by a master weaver whose sisters were active members of the Center. This initiative caused a stir in the local society, which was attached to traditions and did not like the idea of women becoming weavers in a profession that had been exclusively male until then. Very quickly, the tensions calmed down.

This was how the three areas of activity evolved: handweaving, classical embroidery and free artistic embroidery, associated to naive art. This does not take into account the ancillary areas, such as warping, work on the spinning wheels, winding the wires to supply the shuttles, administration, keeping accounts and inventories, financial operations, etc. Many exhibitions of their works have taken place since 1963 in Egypt itself as well as in Europe and Northern America.

Today, the AUEED struggles for more appearance and presence of this historical heritage in the national and international societies, so it participates in all available local and worldwide possible exhibitions. AUEED participated in the Climate Summit Conference COP 27 in Sharm Al-Sheikh, Egypt, in 2022, answering a kind invitation of the Egyptian Ministry of Culture, where it displayed and sold textiles and embroideries produced by the women of the Centre in front of visitors from more than 190 countries. The AUEED also works to train new generations of weavers and embroiderers to ensure the protection of the know-how of the antique culture of this city and its transmission from the old generation to the next.

The Community Center of Akhmim personnel are composed by:

- 1) 150 girls and women who work as handweavers, and/or embroiderers (classical/free spontaneous). A group of these women work as well in the ancillary areas, such as warping, work on the spinning wheels, winding the wires to supply the shuttles, administration, keeping accounts and inventories, financial operations, etc.
- 2) Their age varies between 19 and 75 years old. The elders usually teach the young ones the knowhow in both handweaving and embroidery
- 3) A Centre Manager who holds an experience of over 20 years in social Work and in weaving.
- 4) An Academic and artistic consultant who holds a MA in Egyptian Textiles from Cairo University.
- 5) A Project Director who holds a High Diploma in Folk Arts, with special mention on Akhmim Free Spontaneous Embroidery, from the Academy of Arts, Cairo. The Director of the Project published a book (The Tales of Akhmim Women) which document this art, considered to be an extension of the ancient Egyptians' drawings on the walls of temples and tombs.
- 6) A general administration of the NGO in Cairo who is strongly supporting their activities.

AUEED works with more than one group that practice and transmit intangible cultural heritage:

The Community Center of Akhmim, which revives the weaving and embroidery heritage of Akhmim, as described earlier.

The Wood Workshop of Hagaza, created in 1986 to revive the wooden crafts of this historical village of carpenters and protect it from extinction.

The Choir of Upper Egypt, founded since more than 30 years ago to revive the artistic and musical cultural heritage of Upper Egypt and preserving it from loss. The group currently has 65 singers, story tellers and musicians.

The Choir of Thebes, which reproduce folk songs and dances from the Nubian Artistic Heritage of Upper Egypt. The team currently includes 35 boys and girls, giving the opportunity to make the child feels the importance of his role in society.

The Classical Tahtib and the Modern Tahtib Groups, playing and dancing with the Egyptian wooden stick. Most of the Tahtib practitioners were only men, especially in the rural areas where the stick was used by the people as a sign of masculinity. The rules of the game are based on the values of mutual respect, friendship, courage, strength, chivalry and pride. Tahtib was included in

the List of Intangible Cultural Heritage of Humanity in the Unesco in 2016, through an application submitted by AUEED.

In all its activities, AUEED develops intellectual, cultural and artistic awareness of children, youth and adults, consolidating values of coexistence, citizenship, tolerance and peace-building, by providing an environment that allows interaction, mutual learning and free expression, to enable them to discover themselves, their potential and capabilities by using all available technical tools and capabilities.

Furthermore, AUEED set a child protection policy and procedures, including the internal procedures committed by the Association to provide a safe environment for children and young men and women to protect them from harm, abuse, while they are in AUEED work area.

AUEED ensures that all the staff is fully aware of their duties and responsibilities in implementing the policy. All employees have signed the Code of Ethical Conduct, which includes appropriate and inappropriate practices of employees.



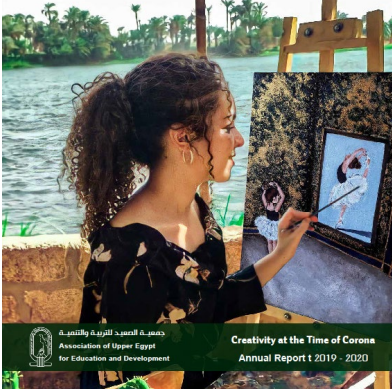
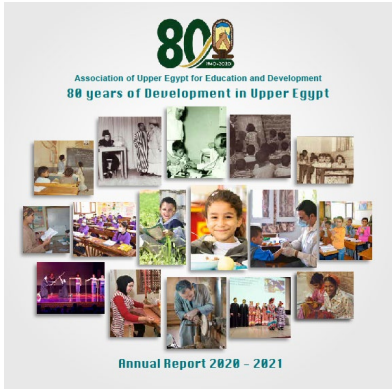
