B.1. Describe your organization's contribution to strengthening institutional and human capacities for safeguarding intangible cultural heritage.

FIAT-IFTA is a worldwide organization of the funeral sector with members from over 70 countries representing every continent of the world. The organization provides advocacy, education, information, products, programs and services to help members to enhance the quality of service to be eaved families in all countries.

The International Council of Direction of FIAT-IFTA is made up of 45 National Members, which in turn represent funeral branches in their respective countries – in total over 22,000 companies around the world.

One of the clear objectives of the organization is the safeguarding of the global funeral heritage, working with partner organizations to create awareness among governments and other international bodies.

FIAT-IFTA has its own Intangible Heritage Committee whose remit is to create awareness and to formulate concrete actions in co-operation with National Members. This promotes the issue of intangible cultural heritage to a significant proportion of the funeral industry worldwide as onwards to many local communities and thousands of individuals.

Despite the challenges presented to the funeral industry by the Covid-19 pandemic, some important steps were taken during the period since our last report in 2019. The information in this report will give an insight of some initiatives of FIAT-IFTA and its members in many parts of the world, which demonstrates our commitment to safeguarding intangible cultural heritage.

B.2. Describe your organization's participation in activities related to the transmission of and education for intangible cultural heritage. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

FIAT-IFTA is committed to the transmission of knowledge concerning intangible cultural heritage both among its members and to the wider society.

The organization is expanding its Educational Program for members (previously known as its Exchange Program). A number of initiatives have taken place under this program. One of them was a pilot project where a member from Parque de Las Memorias in Bolivia participated at a training program in Japan. The training took place in May 2019 and was organized by ZENSOREN, the Japanese Funeral Organization. The objective was to learn about the industry in Japan as well as local funeral traditions and rituals. This project will serve as a template for other such initiatives.

The Program was hindered by the pandemic due to travel restrictions and the organization is now looking in to expand this particular project, including offering financial support to applicants.

Also under the remit of the global Educational Project, FIAT-IFTA is supporting a course in Mexico in conjunction with Group Gayosso and the Instituto Tecnologico de Monterrey. The course is dedicated to training for funeral managers and features a module on the Intangible Cultural Heritage of Funerals.

In 2022, the organization established Yan 'an Intangible Cultural Heritage Inheritance and Protection Base (located at the Xianheling Cemetery and Funeral Home) which is dedicated to the study and transmission of knowledge concerning local funeral practices.

Additionally, FIAT-IFTA is continuing to forge new relationships with institutions for the transmission and education of intangible cultural heritage, including funeral museums in Austria (Bestattungsmuseum Wien Museum) and P.R. of China (Shanghai Humanism Memorial Museum).

Work is underway on the next issue which will be presented at the organization's conference in Cracow in 2024. The organization has created a framework for research and a set of guidelines for recording information to ensure a consistency and quality between contributors. National Members have been engaged in this research which has been communicated via the organization's conferences, email and social media.

Fifteen items of intangible cultural heritage were represented in the report representing all parts of the world, including the Aboriginal Death Ritual (Australia), the Role of Music in traditional African American Funerals (USA), Mortuary Rites (Japan), Funeral Customs of the Sani Minority (P.R. of China), Traditional Oromo Burial Practices (Ethiopia), Carved Grave Markers (Hungary) and Giant Mayan Kites (Guatemala).

Other work undertaken has included:

- establishment of a database of Chinese funeral and burial cultural heritage that includes 251
   ICH items, including five world-class items,
- co-operation between our National Member in China and the Rites Research Center of Peking University to hold an academic seminar in April 2019 on "Mourning Clothes, Rites and Rites",
- research on Intangible Funeral Culture on indigenous communities in Brazil by the National Member in Brazil, AFAI (Associacao Funeraria de Assuntos Internationais), Some preliminary research has been done on Bororo funeral Rituals as well as Karuap Funeral Rituals. Anothes scope of the project is the research "Funeral Flower Wreaths" in Brazil.
- research on funeral traditions and customs in Mauritania, working with our local member Pompes Funebres Mauritanie.

Many of the National Members liaise directly with governmental, private and other nongovernmental institutions on various aspects of the funeral industry and through this dialogue, the organization seeks to pursue the objective of raising awareness at an institutional level of the need to safeguard intangible cultural heritage.

One example of this co-operation was the assistance given to the 101 Institute of the Ministry of Civil Affairs in China to compile the series of Funeral and Burial Culture System and to complete a cultural research report entitled "Funeral Customs in Northern Shaanxi".

B.5. Describe your organization's participation in promoting the role of intangible cultural heritage and its safeguarding in society. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

FIAT-IFTA has added the subject of Intangible Cultural Heritage as one of the core projects of the organization, and has created a dedicated committee to address the subject. The Committee is lead by Mrs. Yuanyuan, from the Chinese Funeral Association. Significant steps have been taken by China and in 2019 the Committee sent an invitation to all National Members to follow this lead. With the advent of Covid-19, we did not make as much progress as we would have liked, however some important steps have taken place.

One of the initiatives is to have a dedicated timeslot during our conferences for the discussion of intangible cultural heritage.

This initiative was introduced at our conference in Yokohama, Japan in June 2021, on the occasion of the celebration of 50 years of the organization. The organization was honored to receive a presentation on the subject of "Japanese Culture to the Future" from Her Imperial Highness Princess Akiko of Mikasa, from the Imperial House of Japan. It was an insightful presentation which helped immensely to promote the role intangible cultural heritage and its safeguarding in society.

During our conference in Budapest in June 2022, a presentation was received from Gábor Móczár, representing the National Heritage Institute of Hungary, which works on asset management for several multicultural cemeteries and acts as an umbrella organization uniting the national and historic memorials of Hungary.

**B.6.** Describe your organization's participation in raising awareness about intangible cultural heritage. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

FIAT-IFTA acts as an agent for the transmission of ideas, goals and objectives from UNESCO to the organization's widespread global membership and from there into the communities that those members serve.

FIAT-IFTA is raising awareness via its participation at funeral fairs, where, by engaging with individuals and companies, both members and non-members, the organization is addressing the subject of intangible cultural heritage including publicization and presentation of the Funeral Heritage Report. During the last year alone, we were present in Dusseldorf (Germany) at the BEFA exhibition, in Coventry (United Kingdom) at the NFE Exhibition, in Bologna (Italy) at the FENIOF, and in Baltimore (United States) at the NFDA Exhibition.

Two other examples of how the organization is raising awareness in society at large include the production of television documentaries and the creation of exhibitions.

An example of the first was the production of a documentary film on Mourning Clothes in Northern Shaanxi, in cooperation with ICH inheritor, Liu Shabao, and the follow up publication in 2019 of a book named Marriage and Funeral Customs in Yanchuan.

An example of the second was the opening in 2022 of a public exhibition entitled *Funeral Customs of the Northern Shaanxi* at the Xianheling Cemetery. During the exhibition, we put on a series of cultural intangible heritage research activities, life education activities, and skills competitions for ICH inheritors. Meanwhile, traditional intangible culture education and research

will be conducted for primary and middle school students.

B.7. Describe your organization's participation in facilitating the engagement of communities, groups and individuals, as well as other stakeholders, for safeguarding intangible cultural heritage.

The very nature of FIAT-IFTA makes it an organization embedded in the communities where each member operates. Dealing with funerals is always an emotional and sensitive matter and the participation and involvement of the community in particular with strong funeral traditions is pivotal.

One factor we have perceived is that many communities do not view their traditions, rituals, etc. as intangible cultural heritage, and it is the aim of the organization to step by step make them aware of the importance of their heritage as well as potential risks they face.

The many initiatives stated in this report, take place with and for the communities the industry serves. A further example is the World United for Life, an initiative undertaken by the FIAT-IFTA Regional Member in Latin America, ALPAR with the involvement of many Countries around the world. The initiative started in 2012 with the objective to celebrate life in different cultures and the last event which took place in September 2022 had the participation of 38 Countries.

- Mexico (Anemex, Mexican Association of Funeral Directors)
- Austria (Bundesinnung del Rauchfangkehrer und der Bestatter / Federal Association of the Funeral Industry)

The objective of this committee and the organizations they represent is to work on forging new relationships and projects relating to intangible cultural heritage.

Many other organizations mentioned in this report, have been taking part in discussions and collaborating with FIAT-IFTA in ongoing and new activities which reflect the scope and reach of the organization's Intangible Cultural heritage project.

This was an important step for the organization and will serve as a beacon project for others to follow.

Through the strengthening of its Heritage Committee and participation of its members via contacts at National Level in different countries, hopes in the future to further participate in the drafting of national Periodic Reports and believes that it has the ability to make a useful

contribution.

- To make use of the social media and other online communication to connect members for professional information exchange, and provide support to members in various forms such as expert consultation;
- 3. To Produce and publicize the Funeral Heritage Report.
