This was due to local lockdowns as well as to MHI's sense of responsibility to prevent the spread of COVID-19 by limiting travel and holding of in-person activities. This was an acknowledgement that a) ICH custodians are often more vulnerable due to being (generally) older, and b) that the whole community is more vulnerable due to poverty.

#### Strengthening of human capacities

MHI has continued to build the capability of staff and community members in Timor-Leste in ICH research, data management and modes of transmission for the purpose of ICH safeguarding. MHI Directors mentor staff to integrate ICH into regular activities, such as our youth performing and visual arts programs. For example, by including traditional dances in performing arts classes. MHI also builds the capability though one-off projects. For example, in 2020, MHI received a grant from the University of California Los Angeles (UCLA) Library's Modern Endangered Archives Program. The purpose was to digitise the endangered vaihoho (sungpoems) collection of local Fataluku cultural researcher, Justino Valentim (deceased). While UCLA's focus was on preservation of archives, MHI's was also on the safeguarding of vaihoho as an element of ICH. MHI staff worked with the family of Justino to:

- Locate and digitise the vaihoho collection.
- Conduct further cultural research about the vaihoho with the community members who had originally shared the vaihoho (or, when deceased, with their families).
- Document the research findings and add the new data to the digitised collection.

The digitised collection is now stored in the archives of UCLA as well as with MHI and the Valentim family. A book of the collection was produced for community members to share knowledge about this element of ICH. Throughout the project, MHI Australian volunteers provided training and mentoring to MHI staff and the Valentim family in material culture conservation, digitisation processes and the identification and collection of missing ICH information. Advice was also provided by UCLA. The project was important in that a number of the vaihoho custodians had already died, and of the custodians who were still alive, the majority had forgotten some or all of the vaihoho they had shared with Justino. Custodians expressed happiness that the vaihoho had been returned to them and that the vaihoho were now safeguarded and could continue to be passed on to future generations.

In 2019, MHI support its Team Leader and Cultural Research Manager Ildefonso da Silva to undertake training to advance his video editing skills using the software Adobe Premier Pro. These skills are essential for creating viewer-friendly ICH videos that support transmission and education.

In the second half of 2018, MHI supported its (then) Team Leader Nelinha Pereira to undertake an English language scholarship in Melbourne, Australia. The scholarship was awarded by *Matadalan Ba Malu* Timor-Leste Research Program, RMIT University. This program was established for women from Timor-Leste who display outstanding community-mindedness and leadership. The scholarship included an internship at the Box Hill Community Arts Centre to support Nelinha to further develop her skills in the management of a cultural organisation. MHI provided accommodation and additional financial support.

MHI has also continued to strengthen staff capability in a range of skills that support safeguarding activities, such as program planning, project management, document management, evaluation, engagement and communications.

#### Strengthening of institutional capacities

MHI is co-located with the State Secretariat for Arts and Culture (SEAC) in the Lautem Cultural Centre. The Lautem Cultural Centre is a facility that was conceived of by MHI and realised in partnership with the Government of Timor-Leste. A government facility, MHI runs the centre's programs (the only regular activities to be delivered in the centre), which include delivery of daily visual and performing arts classes, an exhibition and cultural performance program, and other one-off cultural projects. These contribute to ICH safeguarding through sharing ICH with participants and audiences. MHI supports local and national SEAC staff to be involved in and

learn from MHI safeguarding activities. SEAC regularly requests MHI to deliver or be involved in delivery of activities for SEAC based on MHI's expertise.

#### **Educational activities**

MHI continues to help safeguard ICH by providing ongoing opportunities for young people and their communities to learn about, express and form stronger connections to ICH through the programs we run out of the Lautem Cultural Centre. MHI established this centre with the Government of Timor-Leste in 2013. Through the Youth Arts Program, students learn traditional and new visual and performing arts skills. They explore elements of ICH with MHI staff and community custodians of cultural knowledge and practice. They use these elements as inspiration, giving them expression through the creation of new works.

MHI cooperates with schools in Lautem to deliver opportunities for young people to engage with their ICH and understand its importance for sustainable development. For example, in 2019, the Government of Timor-Leste announced the country's aim to become plastic-neutral, and in February 2021 a ban on single-use plastic came into effect. Despite the ban, use of single-use plastic bags continues to be prevalent due to limited community awareness and understanding of the ban, continued availability of single-use plastic bags, and a market-deficiency in sustainable alternatives. In response to this issue, MHI held an environmental workshop with 50 students from the Central Junior High School in October 2021. The objectives of the workshop were to a) increase students understanding of the impact of plastic bags on the environment, b) equip them to help address this issue by making and using traditional woven baskets and, in doing so, c) support ICH safeguarding through transmission of knowledge and skills. In the workshop, staff from the State Secretariat of Environment presented the government's policy and implementation plan, MHI's Community Engagement and Impact Officer Thomas Lopes shared information on the impact of plastics on environmental and human health, and then five women basket weavers (contracted by MHI) provided hands-on training in the production of traditional baskets. The workshop was a great success, with evaluation revealing that:

- 89% had gained new cultural knowledge and skills in basket-weaving
- 68% had gained new knowledge of plastic bag pollution and its negative impact on the environment
- 95% felt that the workshop had been important to them (no response was given by the other 5%)
- 92% reported they would like to use traditional baskets instead of plastic bags in their daily life
- 92% intended not to use plastic bags in future (no response was given by the other 8%)

The Director of the Central Junior School was so pleased with the workshop and the level of engagement experienced by her students that she subsequently asked MHI to provide daily creative cultural workshops for her 400 students. However, due to funding constraints, MHI was unable to accommodate this request; we continue to look for funding to enable us to meet her request.

Other examples of MHI's activities supporting transmission and education follow below.

Performances/events sharing and exploring ICH

MHI produces monthly cultural nights in which MHI Youth Arts Program students and other community members perform one of more of:

- Traditional dances
- Modern dances incorporating elements of traditional dance
- Traditional music
- Modern music incorporating elements of traditional music
- Traditional sung-poems and poems
- Short theatre works including incorporating expressions ICH

The different works are introduced with a short overview of the ICH involved. The artworks of MHI visual arts students are also exhibited as part of the monthly performances. These often draw inspiration from or depict elements ICH and associated material culture.

MHI also puts on other events, such as those created for national celebration days. For example, in July/August 2021, MHI ran a school holiday program in which participants developed theatre, dance and drumming works (both traditional and modern) to commemorate FALINTIL (the Armed Forces of National Liberation of Timor-Leste) Day on 20 August. These works were performed at a concert staged by MHI at the Lautem Cultural Centre. Local musicians also performed and artworks created by MHI's visual arts student that celebrated culture and history were exhibited.

In 2019, MHI contracted performance artist Lena Caminha from Teatro Timor to work with young students from the MHI Youth Arts Program to create a theatre performance for community. Four short performance pieces were created by the students, including one that explored issues related to *barlake* (bride price practices) in the modern social context. This was a theme proposed by the students and for which they looked at how *barlake* had evolved from its original purpose (equal exchange of goods to cement family relationships) and practices to its current practices.

#### **Mother Tongue Books**

During 2018-2020, MHI produced five different children's picture books published in three mother tongue languages. One of the books, *Let's Count! Traditional Instruments of Lautem*, supports children to learn about their cultural heritage at the same time as developing numeracy and literacy skills.

In 2021, MHI worked with young women to implement the creative research project *Honouring Female Veterans of Lautem Project*. Funded through a Returned Australian Volunteer Network (RAVN) *Go Back Give Back* grant, this project sought to develop public recognition of the contribution of women and their ongoing role in building strong and peaceful communities as freedom fighters, mothers, grandmothers, mentors and community leaders. Many women in Timor-Leste played a vital role in the nation's fight for independence and yet very little is known about their contribution. To publicly honour the Timorese veteran women, 20 women from across the Lautem municipality were invited to share their stories, reflections, life learnings and advice on how to have positive family and community relations. The women were interviewed by 20 young female participants, supported by MHI staff skilled in research. The young female

participants recorded the women's stories in writing and MHI staff captured the stories on video. Rico then worked with the MHI team to edit the recordings into documentary videos. The young participants painted the veteran's portraits at the Lautem Cultural Centre under the tutelage of MHI's Youth Arts Program Leader Cesario Lourdes and with support of MHI senior art students. The portraits, written stories and documentary videos of the women were then publicly celebrated through an exhibition at the Lautem Cultural Centre. The women veterans were in attendance during a school holiday program so that students could meet, hear from, and ask questions of them. The project received extremely positive feedback from participants, community, government and funders.

During the reporting period, MHI continued to edit video footage from its endangered ICH research project (implemented before accreditation). The videos and other research data continued to be organised and uploaded to a digital collections website (OMEKA).

In May 2021, MHI wrote an article about the *vaihoho* (sung-poem) collection of Justino Valentim with the support of former MHI volunteer and writer Marian Reid. Entitled *Vaihoho*, the article explores *vaihoho* as a cultural expression, its importance for community and the staff members' journey to safeguard Justino's collection. The article was published in Garland Magazine which is produced by the World Crafts Council Australia (a national entity of the World Crafts Council Asia Pacific). The magazine is a platform for thoughtful writing about craft and design within the Asia-Pacific region and aims to promote dialogue and opportunities. #### **Speaking events**

In 2021, Director Holly Schauble was a guest presenter at an event organised by the Mornington Peninsula Friends of Lospalos community group. Holly spoke on the role of culture and development in Timor-Leste, including the importance of ICH safeguarding.

In 2019, the MHI team took part in the Timor-Leste Studies Association' Conferences New Research on Timor-Leste. MHI's Cultural Research Manager Ildefonso da Silva presented on MHI's research project supporting Fataluku people to record, store and digitally share their endangered forms of intangible cultural heritage expression. This included discussion about the role of ICH and why it's important to safeguard it.

In the second half of 2018, MHI team member Nelinha Pereira was a guest presenter at the Melbourne East Timor Activity Centre. Nelinha was in Melbourne on an English language scholarship and she spoke to the audience about MHI's activities in Timor-Leste, including the importance of ICH and our work with communities to safeguard it.

In the second half of 2018, MHI Director Holly Schauble presented on a panel at the 22nd Biennial Conference of Asian Studies Association of Australia, hosted by the University of

Sydney. In her presentation titled *Using the OMEKA Platform to Share Cultural Heritage*, Holly discussed the progress of MHI's work to support the Fataluku people of Timor-Leste to safeguard critically endangered ICH elements, which included discussion of the role of ICH.

MHI raises awareness about ICH as a matter of course in all its activities, as can be seen in previously detailed activities.

During the reporting period, MHI shared ICH research videos and associated information from its endangered Fataluku ICH research project on Facebook. These videos (in Fataluku language) have been viewed thousands of times, with the most popular video having been viewed 24,800 times. The videos are also available on YouTube and the OMEKA. In the videos, community members share their knowledge and practice of endangered forms of Fataluku cultural expression. On the OMEKA site, recordings are accompanied by additional cultural information and other metadata. The OMEKA site requires a lot of data and good internet connection to play the videos, both of which are problematic in Timor-Leste. Consequently, MHI is now in the process of creating a dedicated website with embedded YouTube links that will result in improved quality and accessibility for Fataluku communities in Timor-Leste and their diaspora. This project is being supported by the IOM in 2023.

MHI also shared ICH research findings from other projects, including the Portrait Avo (grandparent) project which support young people to a) conduct research interviews with their grandparents about their personal histories and culture, b) paint their grandparents portraits and then c) share this information and art with community through a public exhibition.

#### **Exhibitions**

In November 2022, MHI was invited to participate in the Festival of Culture and Music on Atauro Island, organised under the patronage of the President of Timor-Leste. MHI exhibited students' art works and MHI staff shared information about the role of ICH MHI's work with communities to safeguard it, including with the President of Timor-Leste and government ministers.

In November 2021, MHI was invited to participate in the Manatuto Arts and Crafts Festival. MHI exhibited past and present students' art works and showcased information about MHI's cultural activities, including ICH safeguarding activities. A small number of MHI senior students had the opportunity to attend with MHI staff. The MHI exhibition drew a large crowd, and visitors were most impressed with the students' paintings and environmental artworks. The Minister of Education, Youth and Sport, Bonifácio Mau Coli dos Reis, and Vice Minister of Trade and Industry, Domingos Lopes Antunes, attended MHI's exhibition and were very interested to learn about the organisation, congratulating MHI on its work.

In September 2018, six MHI senior art students represented their peers at their very own art exhibition at the Xanana Reading Room in Dili. More than 100 student works were displayed in mediums of glass painting, lino print and papier mache. The theme of exhibition was entitled *My family, my culture: strengthening positive relationships through art.* Opening night drew a large crowd and the MHI students and Youth Arts Program Leader spoke about the role of ICH in developing and maintaining positive family (and community) relationships. The event was supported by Volunteer Service Abroad New Zealand and the Xanana Reading Room.

MHI facilitates engagement by partnering and co-designing safeguarding projects and program activities with individual ICH custodians, communities and government and non-government organisations.

MHI cooperates with village, municipal and national government in Timor-Leste to deliver activities that safeguard ICH. For example, in December 2020, MHI was invited by the State Secretariat for Art and Culture to help deliver the National Cultural Festival in Lospalos. MHI provided advice on how to organise a festival and also contributed by organising a cultural goods exhibition/market which facilitated community engagement with producers to learn about traditional crafts and other goods. MHI also produced an exhibition MHI students' artworks incorporating/inspired by ICH (for example, depictions of dance) as well as ICH research videos. Community members were very engaged in the exhibitions and enjoyed the opportunity to learn about and discuss ICH and its safeguarding.

MHI regularly engages with the Lautem Municipal Administration to discuss plans, activities and approaches, and to seek advice and provide it when requested. For example, in July 2022, MHI participated in a meeting at the Municipal administration for all NGOs to discuss their annual implementation programs. MHI presented its program and identified how this helps deliver on the National Development Plan and various international cultural conventions (such as the 2003 Convention). MHI's positive engagement has led to the Municipal Administration supporting MHI's activities, often speaking at MHI events as well as providing written support for MHI's various funding applications for ICH safeguarding activities.
