B.2. Domain(s) in which the organization is active

Una Voce Polonia is an association which is particularly concerned with the highest manifestation of the intangible cultural heritage of the Catholic Church, that is, the traditional Catholic liturgy, understood as all the legitimate Latin liturgical rites of the Catholic Church of the rite codified at the Council of Trent, in the form published no later than 1962, together with all subsequent modifications of that form made by the Holy See.

Its aim is to safeguard and promote the intangible heritage of the Catholic Church in Poland, and in particular to actively support the spread of the Extraordinary Form of the Roman Rite (Tridentine Mass) in the Catholic Church. Members of the Association follow events related to the spread of the Tridentine Mass in Poland and worldwide. The statutory aims of the Association include: acting for the benefit of parishes, pastoral centres and other types of organisations where the traditional Catholic liturgy is cultivated; promoting the Latin language, Gregorian chant and the musical heritage, i.e. sacred polyphony; protecting works of sacred art and architecture; educating those who wish to preserve the intangible, living heritage of the Church through active participation in the liturgy (both faithful and priests); and helping to create and develop stable groups of faithful who wish to participate in celebrations of the traditional Catholic liturgy.

This intangible religious heritage that is both outstanding and in urgent need of safeguarding, since the liturgical reforms of the Catholic Church that followed after the Second Vatican Council have largely abandoned and forgotten the rituals and social religious practices in question, thus seriously limiting the transmission of this living heritage to future generations. There is only a limited (but thanks to the awareness-raising and educational efforts of Una Voce Polonia, among others) growing social group of priests and faithful who are rediscovering this heritage and living it in their own lives.

Una Voce Polonia is not a religious organisation. It does not interfere in the liturgical, spiritual and pastoral competence of the Church, but only collaborates with ecclesiastical and clerical organisations in the implementation of various projects in accordance with its statutory objectives.

- a) to make available to all the faithful the Roman liturgy in the usus antiquior (i.e., the old form of the Roman Rite), considered a precious cultural treasure to be preserved;
- b) to guarantee and make available in a real way the possibility of using the Extraordinary Form of the Liturgy to all who so desire, in the conviction that the use of the Roman Liturgy in force in 1962 is a right granted for the benefit of the faithful and must therefore be interpreted in favour of the faithful for whom it is primarily intended;
- (c) to facilitate reconciliation in the Church by acting in the spirit of mutual respect.

Foederatio Internationalis Una Voce, of which we are a member, is an organisation recognised by the Congregation for the Doctrine of the Faith as representing lay Catholics attached to the Extraordinary Form of the Roman Rite.

The aim of the Una Voce Polonia Association is to stimulate, support and develop initiatives in the form of actions or projects, exclusively in the public interest, for the benefit of the community at large, aimed at the development of Catholic culture, consisting in particular of safeguarding, transmitting, practicing and fostering of:

- oral traditions and expressions of the Catholic Church, particularly the Latin language as a vehicle of the Church's intangible cultural heritage and the Gregorian Chant
- social practices, rituals and festive events of the Catholic Church, especially those which fell into oblivion after the 2nd Vatican Council. Among other things, this means nurturing and rescuing from oblivion traditional, popular religious customs and rituals that have either been completely suppressed or greatly reduced, stripped of their original richness.
- traditional craftsmanship (in particular, artistic embroidery (gold thread embroidery and silk shading) for decorating liturgical vestments, crochet and block lace for decorating these vestments, and techniques for repairing ancient liturgical vestments).

- e. cooperating with other national and international organisations with a similar profile in order to develop joint approaches concerning the elements of intangible cultural heritage they have in common, as well as fostering the exchange of information among them.
- f. making full use of information and communication technologies by maintaining the Community's website and social media profiles;
- g. financially supporting public services: education of seminarians of traditional seminaries, maintenance of monuments of ecclesiastical art, recreation of children and youth combined with traditional Catholic education;
- h. financially supporting religious worship connected with the traditional Catholic liturgy;
- i. organisation and financially supporting activities of an informative and educational nature, in particular seminars, training courses, conferences and competitions, cultural events such as festivals, fairs, shows and exhibitions.
- j. organisation and financially supporting of dissemination, promotion, information and printing activities, including the development and printing of brochures, leaflets, posters, the development and distribution of audiovisual material, the creation of websites
- k. preparation and dissemination of other information and promotional material;

Several of the members have majored in the field. In their areas of residence, they cooperate

- Gregorian and polyphonic choirs;
- Architects and visual artists who create Catholic places of worship as places to be used by communities as cultural spaces in which their intangible cultural heritage is safeguarded, and as places for transmitting traditional knowledge and skills and thus contribute to intergenerational dialogue;
- Collaboration with scholars publishing articles and books on the history and present day of the Tridentine Mass.
