



Created in 2017 as a soft law, agreement-based framework for sustainable, fair and equitable relationships with Craft Custodians and Traditional Knowledge Custodians who belong to Indigenous Peoples, Ethnic groups and Local Communities.


A private digital documentation (*inventorisation*) of Oma traditional textiles and associated TK (*Oma specific designs and motifs, cultural significance, and production techniques*) affirming Oma collective custodianship rights over their TCEs created to ensure that the community has control over how their intangible cultural heritage is accessed, used and commercialised.



- A platform to initiate the process of Free Prior and Informed Consent
- A tool to facilitate fair and equitable uses of Oma TCEs between Oma custodians and fashion, tourism and creative industries stakeholders ensuring there is no misuse or misappropriation
