**B.1.** Describe your organization's contribution to strengthening **institutional and human capacities** for safeguarding intangible cultural heritage.

The main area of expertise of our organization is field research, documentation and inventorying of ICH. While carrying out these studies and activities for the protection of ICH, we closely cooperate with public institutions, municipalities, academic institutions, NGOs and experts, local communities, tradition bearers and researchers. These collaborations strengthen our institutional

capacity.

Our active role in Izmir ICH Provincial Determination Board also contributes to increasing our institutional capacity.

Within the framework of our Foundation's Handicrafts Research Program; in July 2022, we established the Izmir Traditional Handicrafts Centre (IGSM) in order to contribute to the survival and transfer of the tradition to the future by developing methods based on cooperation and solidarity with the representatives of the handicraft tradition living in Izmir. This platform aims to strengthen human capacity among artists on ICH and to create a network among artists.

Our organization strives to create activity programs, develop resources and materials in the field of ICH, especially for children and young people. In order to raise awareness of children and young people about their intangible cultural heritage, we started from the idea of developing an educational and awareness material based on digital and visuals. In 2021, we created animations about ICH. In the work prepared under the consultancy of educational consultants and folklore experts, we tried to emphasise that ICH is a living cultural heritage and its relationship with the natural environment. We ensured that these animations, which explain the 2003 Convention and its five main areas, are accessible and usable by everyone.

With the in-kind support of the EU Sivil Düşün Programme, we prepared the Video Clip Project titled 'Tell Me a Tale, Let It Be in My Mother Tongue' within the scope of mother tongue in order to transfer fairy tales, one of the important oral culture products of our culture, from generation to generation and published it in 2023.

As a permanent member of the Intangible Cultural Heritage Board of Izmir Provincial Directorate of Culture and Tourism, our organisation directly participates in inventorying activities.

We have been carrying out inventory studies in the fields of culinary culture, toy culture, rituals and handicrafts based on field research since our establishment. These studies are carried out by the founding members of the foundation and volunteer members. The works carried out entirely on a voluntary basis are archived and shared on our website.

Within the scope of the Culinary Culture Research Programme, we have been conducting an inventory study on traditional female cooks since 2022.

Within the scope of our Toy Research Programme, our inventory study based on 20 years of field research data on the inventory of traditional toys has been completed. As a result of the study; our book titled 'Anatolian Toy Culture' was published in November 2023 by Yapı ve Kredi Publications, which has a wide national distribution network. A decision was taken to publish the book in English.

We have established contact with some village associations and communities to conduct ICH inventories. We voluntarily support these communities on the scope of the 2003 Convention and the methodology for creating an inventory of their cultural heritage.

Türkiye records intangible cultural heritage elements through the National Inventory System. Provincial inventories constitute the basis of the National Inventory System. Inventory works in provinces are carried out under the coordination of Provincial Directorate of Culture and Tourism. Our organization has been a permanent member of the Intangible Cultural Heritage Board of Izmir Provincial Directorate of Culture and Tourism since 2014. It is actively involved in all activities carried out within the scope of the Board. In these meetings, we share our recommendations on developing legal and administrative measures for the protection of ICH and try to increase the cooperation between tradition bearers and the board.

Based on the idea of using new technologies for documenting, sharing, promoting the protection and preservation of ICH and transferring it to the future, the website titled 'Folk-Portal - Turkey Folklore Portal', which we launched in 2018 in order to inventory ICH elements on a common digital platform, is being developed and maintained. Folk Portal offers a sharing environment and new perspectives to individuals, groups and communities - especially young people - who are keen to identify and maintain their intangible cultural heritage. This project was supported by the EU Sivil Düşün Program.

In order to increase the visibility of ICH and raise awareness, we organised the 'Living Heritage Türkiye Photo Exhibition' in December 2023 on the 20th anniversary of the 2003 Convention. In the exhibition, which included 40 photographs on the theme of intangible cultural heritage in the archive of our organisation, university students, academics, local government representatives were informed about the photographs in the exhibition and the 2003 Convention. 'Intangible Cultural Heritage-Türkiye Workshop and Panel' was organised within the scope of the exhibition. These activities were carried out in cooperation with Çukurova University Faculty of Communication, Centre for Intercultural Communication and Seyhan Municipality.

We try to emphasise the 2003 Convention and the role of civil society through conferences, workshops, exhibitions and seminars.

We gave a seminar on the ICH 2003 convention and culinary culture for graduate students at the Mediterranean bieanal of Izmir Metropolitan Municipality in November 2022; at Izmir Chamber of Commerce Museum in October 2024; at Çukurova University Faculty of Communication in December 2024; and at Ege University Turkish World Research Institute in December 2024.

We also carry out studies on the roles of culinary culture, toys and handicrafts, which are our main fields of study, in modern daily life from the perspective of the 2003 Convention.

In many events, we have explained the role of the 2003 Convention in increasing the visibility of the 'Ceremonial Keşkeği Tradition' (the element registered in the representative list) to individuals, producer cooperatives, kitchen chefs, local press and students.

**B.7.** Describe your organization's participation in facilitating the engagement of communities, groups and individuals, as well as other stakeholders, for safeguarding intangible cultural heritage.

In order to encourage artistic works for the effective protection of ICH and to share effective visual records of the elements included in provincial and national inventories; Since 2019, we have been maintaining a website called 'ethnophotography'. Ethnophotography is a project prepared for the documentation, promotion and safeguarding of intangible cultural heritage with photographs. On the website prepared in cooperation with Ankara University Folklore Department, the concept of ethnophotography is explained with written and visual media tools together with the introduction of ICH. The site is open to the sharing of individuals and communities who want to share their ICH themed images together with their descriptions. <a href="https://etnofotografi.org.tr/">https://etnofotografi.org.tr/</a>

CRF's digital and physical archives are available free of charge to tradition bearers and researchers for information on the 2003 Convention and safeguarding measures. CRF encourages tradition bearers and their associations or platforms to protect their ICH and recommends them to follow the Convention.

In the feedback we received from these studies, we witnessed that the research-documentation results and visuals initiated and developed mutual communication. The effects of these exchanges were sometimes a reminder for individuals, groups and communities. Most of the time, groups and communities developed awareness about their intangible cultural heritage through the commonalities and/or similarities in these exchanges. We believe that these and similar processes we have witnessed have contributed to the development of the safeguarding of intangible cultural heritage.

In 2022, UNESCO World Culture Forum conducted a comprehensive survey on the integration of culture into global and national development policies in line with the Sustainable Development Goals.

On 23 June 2023, upon the invitation of the JIAPICH Secretariat of the Intangible Culture Centre based in South Korea, we participated in the 2023 JIAPICH Online Colloquium and made a presentation on our Foundation's safeguarding approaches and main activities under the 2003 Convention.

We focus on intellectual property rights in handicrafts and culinary culture, which are two of the main areas of work of our organisation. In line with our interest in this area, in 2024, at the Forty-Eighth Session of the WIPO Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore (IGC 48), our organisation was accredited to participate in the Committee sessions as an observer.

The report on the research, documentation, training and information activities carried out by our organisation in relation to the intangible cultural heritage elements of Türkiye is regularly sent to the Ministry of Culture and Tourism - General Directorate of Living Heritage and Cultural Activities, which is the executing institution, in order to contribute to the National Periodic Report of Türkiye.

Our organization is directly involved in the creation of provincial inventories.

Some of the CRF experts, as employees of the Ministry of Culture and Tourism, took an active role in the preparation of the nomination files of four elements for the ICH Representative List. The fact that a significant number of our Foundation employees have been educated in Folklore and Anthropology, their field research experiences, the reports they have presented to academic meetings, articles and book studies have enabled them to gain knowledge and expertise in the fields of ICH. Our organisation has competence in traditional cuisine culture, game and toy culture, handicraft tradition and rituals.

Our organization tries to raise awareness about the protection measures included in the file of the elements registered on behalf of Türkiye in the Representative List. We emphasise in all our activities that efforts to implement conservation measures are as important as the registration of the items on the Representative List.

We are an organization with sufficient experience and knowledge in field research, inventorying, training and archiving within the scope of ICH.

CRF is managed by professionals such as folklorists, anthropologists and craftsmen.

Some of the CRF experts also work as Folklore Researchers in the Ministry of Culture and Tourism. Professionals such as folklorists, anthropologists and craftsmen also work at CRF. CRF 's main area of expertise is to conduct field research, documentation and inventory studies on ICH. ICH studies are carried out under four main headings: a) Traditional cuisine culture b) Game and toy culture c) Handicraft tradition d) Rituals. We are an organisation with a high level of experience working in these areas. We are trying to improve this experience.

Some of the CRF experts, as employees of the Ministry of Culture and Tourism, took an active role in the preparation of 4 ICH Representative List nomination files. The fact that a significant number of our Foundation employees have received Folklore and Anthropology education, their experience in field research, the reports they have presented at academic meetings, their articles and book studies have enabled them to gain knowledge and expertise in ICH fields. Our organization has competence in traditional cuisine culture, game and toy culture, handicraft tradition and rituals.

As ICH Provincial Board members, CRF experts take part in the ICH Provincial Board held every year and directly participate in the creation of provincial inventories. For example, a meeting was held on 07.12.2023 to discuss Izmir's intangible cultural heritage elements and living human treasure proposals to be recorded in the ICH National Inventory of Türkiye. During the meeting, the elements of 'Bergama Sword and Shield Game', 'Sea Festival' and 'Quilt Making' were discussed.
